**Notification**

The 1st July, 2022

**No. 11/1/18(PF)-UTFI(4)-2022/9651.**—In exercise of the powers conferred by Sections 3 and Section 22(1) of the Capital of Punjab (Development and Regulation) Act, 1952 as adopted by the Punjab Reorganization (Chandigarh Adaption of Laws on State and Concurrent Subjects) Order, 1968 and all other powers enabling him in this behalf, the Administrator, Union Territory, Chandigarh is pleased to make following amendments in the "The Chandigarh Conversion of Residential Lease-hold Land Tenure into free hold Land Tenure Rules, 1996" as notified by the Chandigarh Administration *vide* notification No. 222-UTFI(3)-95/9345, dated 19.07.1996, namely :—

- 1) These rules shall be called "The Chandigarh Conversion of Residential Lease-hold Land Tenure into Free Hold Land Tenure (Amendment) Rules, 2022".
- 2) These rules shall come into force from the date of their publication in the Official Gazette.
- 3) In "The Chandigarh Conversion of Residential Lease-hold Land Tenure into free hold Land Tenure Rules, 1996", Rule 8 shall stand deleted.
- 4) In "The Chandigarh Conversion of Residential Lease-hold Land Tenure into free hold Land Tenure Rules, 1996", Rule 9 shall be substituted as under :—

"In all cases of Conversion, the Conveyance-deeds shall be got registered on payment of requisite Stamp Duty and Registration Charges. The Consideration amount for this purpose shall be the "Conversion Fee". However, in cases where lease deed has not been executed, the Price/Premium of the site as reflected in the letter of allotment or the predetermined rate as prescribed by the Competent Authority on the date of allotment/transfer shall also be added for the purpose of calculation of Stamp Duty."
